

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to **BUSINESS2MARKETING.COM** and Business2Marketing and Governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to **Business2Marketing** include **businesstomarketing.com**, **B2M**, **business2marketing**, **b2m.guru** and **business2marketing.com**. The **B2M** website is a **Marketing & Advertisement** site. By using the **B2M** website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, **B2M** may collect personally identifiable information, such as your:

- First and Last Name
- E-mail Address
- Phone Number

B2M may also collect anonymous demographic information, which is not unique to you, such as your:

Use of your Personal Information

Sharing Information with Third Parties

B2M does not sell, rent or lease its customer list to third parties.

Tracking User Behavior

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by B2M. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the B2M website.

Use of Cookies

The B2M website may use “cookies” to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you. And can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page.
